2015 At-A-Glance

WesleyLife offers a comprehensive network of services to help older adults remain active and independent, wherever they call home. It's our mission to help those we serve lead healthy, meaningful, fulfilling lives that focus not on limitations, but on possibilities. We strive to transform aging by shining a spotlight on options and opportunity, creating and enhancing the template for those we serve to build their lives exactly as they wish.

Here are some examples of ways our residents and clients demonstrated vivacity and purpose in 2015.

Hearthstone. Hearthstone residents and community members enjoyed a five-month Blue Zones series that focused on the healthy habits of the world's longest-living people. "Blue Zones" is a concept used to identify a geographic area where people have been identified as living measurably longer lives than populations in other areas. We're proud that all WesleyLife locations, including our seven Communities for Healthy Living, are designated Blue Zones Work Sites, obligating us to encourage residents and team members to practice habits that are believed to contribute to longevity.

One of those is giving generously of time and talents, and Hearthstone residents demonstrated that by supporting the ministries of Joshua Christian Academy, making diapers for Haiti, collecting paper products and blessing bags for a local mission, volunteering at local thrift stores,

collecting shoes for a college mission trip, and hosting a pancake breakfast to benefit a nearby camp.

• Park Centre. Through their charitable mission, Park Centre residents purchased items and assembled care bags for the nonprofit Care Bags Foundation, an organization that provides bags to children facing crisis situations. The group was founded in 2000 by then-11-year-old Annie Wignall, granddaughter of Park Centre residents Dorothy and Gerald Carpenter. "Everyone is so proud of the work Annie is doing," said Margot Voshell, Park Centre marketing director.



• **Wesley Acres.** Wesley Acres was brimming with activity through its *Live Well* program, including

the immensely popular Wesley Acres On The Lawn Series consisting of Tai Chi, a Metro Arts Jazz in July Concert, qigong and yoga. The Jazz in July concert series, a staple in Des Moines, has grown to include family activities, food, wine, pony rides, face painting – fun for everyone, regardless of age.



Wesley Acres was first to bring Jon Katz, *New York Times* bestselling author of *Saving Simon*, to Des Moines. Katz read from his award-winning book, which is a heartfelt, thoughtful and inspiring memoir about the ways animals make us wiser, kinder people.

During WesleyLife Week, Wesley Acres residents and team members shared their passion for helping others with a "pay it forward" activity — providing

individuals in need from Greater Des Moines with acts of kindness, generosity and support.



• Edgewater. Edgewater's commitment to its skilled rehabilitation patients extends beyond their stays at Edgewater. In July 2015, past skilled patients were invited to a "rehab reunion" with their nurses, CNAs, therapists, and other staff members who contributed to their rehabilitation journeys. Guests enjoyed hors d'oeuvres, beverages, and fellowship with the team members and fellow patients whom they had come to know during their stays. They were also able to attend a brief wellness presentation and tour the independent living, assisted living and memory support areas of Edgewater.

Edgewater resident Philip Dorweiler, a retired attorney, received the *Sage Over 70* award from *dsm Magazine*. In the nomination process, former Iowa Attorney General Bonnie Campbell called Phil "one of those rare individuals who has been blessed with a keen intellect, a warm and gracious personality, and a commitment to his family, friends and community," and said his sense of humor spreads joy to all who find themselves in his presence. We couldn't agree more.

Heritage House. In May, residents of Heritage House enjoyed their annual Decorah, Iowa, vacations. They enjoyed the sights and sounds of this northeast Iowa tourist destination, including a tour of the Seed Savers Exchange, a nonprofit organization that preserves heirloom plant varieties through regeneration, distribution and seed exchange. In addition, residents and team members took several trips to Lake Anita State Park in southwest Iowa for pontoon rides, fishing, and dinner by the lake. In September, residents and team members caravanned to the renowned Henry Doorly Zoo in Omaha.

Twice a month, residents from Heritage House take part in an effort to sew and decorate clothing for children in Africa with the help of fabric and supplies donated from the greater community.

 Halcyon House. Halcyon House residents "rocked" the Washington community in fall 2015 with their float for the Washington Community Schools' homecoming parade. Residents dressed as rock band members, and rock music streamed from the speakers. Washington High School is located directly across the street from Halcyon House, so residents regularly enjoy an intergenerational partnership that, in 2015, included Iowa's Healthiest State Walk. Numerous high school students accompanied residents on the walk, and a great time was had by all.

• The Village. To honor those who served in the military, The Village displayed 525 flags on the Fourth of July and 650 on Veteran's Day in recognition of the 46 veterans who call The Village their home.

In 2015, residents enjoyed fun day trips to Wesley Woods Day Camp, Lake Ahquabi, the Iowa State Fair, an Iowa Cubs game, and also toured farms in their county. Residents and team members participated in an arboretum walk and enjoyed a stand-up paddleboard demonstration provided by Canoe Sport Outfitters. They supported efforts including "Wear Purple for Maddie" to raise money for a little girl with cancer and fulfilled "bucket list" wishes, including taking a resident to a St. Louis Cardinals game and arranging therapy horses to visit a health center resident who had been an avid horseback rider.

Special Recognition

The Cottages at Hearthstone received an award of merit in the 19th annual Environments for Aging Design Showcase. WesleyLife's design for The Cottages was recognized for innovation, community collaboration, aesthetics, and improving resident wellness and outcomes.

Three WesleyLife Communities for Healthy Living received the 2014-2015 Excellence in Action award from My InnerView by National Research Corporation. The award is based on positive resident satisfaction survey results, which ranked the communities in the top 10 percent nationally. Awards included: Edgewater and The Village, independent living; and Heritage House, assisted living and independent living.

Hearthstone was featured in MidWestOne Bank's "One Smart Move" campaign to spotlight its commitment to Pella and financial partnership to help create The Cottages. Hearthstone is making a difference for Pella's older adults and their families through its emphasis on healthy lifestyles and appreciation for the community's Dutch heritage. The Cottages are based on a household model in which empowered team members work to support older adults in making daily choices.

The National Wildlife Federation recognized Edgewater for successfully creating an official Certified Wildlife Habitat™ site. The garden space improves habitats for birds, butterflies, frogs and other wildlife by providing essential elements needed by all wildlife – natural food sources, clean water, cover and places to raise young.

Park Centre was recognized by the *Newton Daily News* as its Readers' Choice senior living community for Jasper County.

The Village was voted best senior living community in Warren County by readers of *The Record-Herald* and *Indianola Tribune*.

Of the Top 10 stories in the *Washington Evening Journal* for 2015, the Halcyon House building project was voted #2 overall by the Washington, Iowa community.

WesleyLife was named a 2015 Top 150 Workplace by the *Des Moines Register*. The honor is bestowed on businesses that receive high scores in a survey that examines the organization's workplace culture.

Extending Wesley Life's Mission



In 2015, WesleyLife positioned itself to better serve future generations in Atlantic and Washington, Iowa, by launching construction and renovation projects with a combined value of more than \$18.5 million. Both projects were enabled in part by the generosity and support of local donors, and are expected to be completed by the end of 2016.

WesleyLife also prepared itself for future growth by laying groundwork for expansion of Edgewater in West Des Moines and advancing plans to construct a new Community for Healthy Living in Johnston.

Heritage House Groundbreaking and Construction

On June 10, Heritage House broke ground on its \$7 million campus transformation project, which features a lifestyle pavilion that encompasses a wellness classroom, fitness center, salon, café, and gathering space called Heritage Hall.

The project also involves renovating the community's three health center households to provide residents a more home-like environment to gather for conversations and meals. Other transformations include renovation of the kitchen, dining and community areas; a sun porch addition; and extension of the walking trail.

Heritage House has always been an inviting place, warmly welcoming family members and guests. The new pavilion will provide a space for members of the public to experience our hospitality as they enjoy lunch, host a meeting, or participate in support groups, health screenings, educational activities, and health and well-being programming.

Halcyon House Groundbreaking and Construction

Halcyon House hosted its groundbreaking event on June 3, setting the stage for construction of an \$11.5 million project to replace a medical-model health center, built in 1959, with three 18-bed households for long-term care, short-term rehabilitation and memory care. The secure memory care household will be the first of its kind in Washington, serving individuals with advanced-stage memory loss at a location closer to their families.

The project also includes creation of a more identifiable entrance, renovation of several older common spaces and creation of new independent living spaces. Within the new social, person-driven households, residents will have private rooms that

open to a common living room and access to a family-style kitchen/dining area where meals are prepared in view of residents.

The Halcyon House project received a boost in July in the form of a \$160,610 grant from the Iowa Department of Human Services' Civil Money Penalty Quality Improvement Initiative. Funds will be used to purchase household furnishing and new strength-building therapy equipment aimed at reducing the likelihood of falls that can dramatically impact independence and quality of life.



Edgewater Lays the Groundwork for Expansion

Robust market demand spurred plans for an expansion project that will add 35 independent living apartments to Edgewater in West Des Moines.

Edgewater was built in 2009 and is 100 percent occupied, with waiting lists for all floor plans.

When a feasibility study predicted strong future demand, WesleyLife began exploring adding on to the existing complex.

Starting in late 2015, Edgewater built a list of more than 70 names of people who had expressed interest in the proposed new apartments. Presale of the new spaces began in mid-2016, with the project slated for completion by late 2017.

New Community for Healthy Living on the Horizon

During 2015, WesleyLife's leadership and board of directors were busy reviewing feasibility studies, developing investment strategies, overseeing design of a preliminary site plan, and preparing documentation necessary to file a Certificate of Need (CON) with the State Facilities Council to construct a new WesleyLife Community for Healthy Living in Johnston. Approval of the CON was granted in early 2016.

The building site will accommodate a two-story, 50-unit independent living apartment building; a health center; memory care households with 18 units each; a two-story, 32-unit assisted living apartment building; and a one-story, 10,000-square-foot commons area.

WesleyLife is pleased to be able to further its mission and construct the new community, to be named Brio, near its headquarters in Johnston. Ground will be broken in late 2016, and the community is slated to open in spring 2018.



Percentage of Operating Expenses


